We are thrilled that you are interested in applying to Cornerstone Community Group! Before you take the time to complete an application, please be sure that our group is a good fit for your family. Please read the following expectations carefully and also be sure to carefully read through our expectations in the Policy Agreements, which is page four of the application. Thank you!

Parental participation is a key component to the community aspect of Cornerstone. To provide an equitable environment for all, every family must be involved. In order for families to participate in CCG, certain requirements must be met. Please do NOT register if you are unable to participate in these ways:

1. Our host church, Calvary Christian, relies on CCG to do a thorough weekly cleaning of the areas that CCG uses in the church. We pay someone to come in and clean the main areas of the building for us. Each family is required to pay a \$110 cleaning/supply fee. The cleaning fee is due at orientation in September.
2. Each week it is necessary for families to volunteer. Parents are required to be a member of a team that assists in running our community, as well as to function as a door monitor, building spot-check, and/or other jobs that will be announced throughout the year. Please respond to requests that are made of your time during the co-op day.
3. To maintain good standing with our host church and to ensure the safety of all CCG children, children **must** be supervised at all times. Parents must remain on church property at all times. Therefore, parents are not allowed to drop their children at the church and leave. If parents need to leave for any reason for a brief period of time, they must ask another parent to supervise their children. Furthermore, your children may not be unsupervised in classrooms, the halls, or on the playground.

CCG Policy Agreements

CCG Registration Fees

I understand that the registration form and fee is for participation in the CCG community and I must also enroll (and pay tuition to teachers) for each class in which I would like my child(ren) to participate. I also understand that after the stated deadlines my fees are nonrefundable.

Class Fees

I understand that each teacher will charge and collect their own tuition for their classes, all payments are to be made directly to them, and are due no later than the tuition payment dates. There are no tuition refunds if my family leaves CCG mid-year; I understand that all unpaid quarterly payments are still due and I agree that I will pay teachers in full. I understand that deposits are nonrefundable.

Behavior Expectations

I understand that I am responsible to know and follow the Family Handbook. I will also ensure that my child(ren) are aware of and will follow the rules and expectations of CCG, and that teens must sign the behavior contract. I understand that admission to CCG is a privilege, not a right, and that not adhering to CCG's standards could result in the loss of that privilege. I understand that the CCG Board reserves the right to remove my family from CCG for any reason they deem necessary.

I understand that all CCG information will be relayed to the group primarily through the BAND App and occasionally by email. I understand it is my responsibility to regularly check BAND and my email for information and updates regarding our group. I agree that I will respond when requested to do so.

Cleaning Responsibilities

I understand that my family is required to pay the cleaning fee for the year AND to clean up after myself and my child(ren) each week in the fellowship hall, nursery, classrooms, teen room, and all other areas of the church. I understand that eating may only occur in the fellowship hall and there is no eating in the nursery or the teen room. I understand that I may not leave items on the counter in the fellowship hall.

Volunteering

I understand that I am required to volunteer on a regular/weekly basis, both as a door monitor and a member of a team. I agree to sign up on BAND, show up for my volunteer duty, and find a substitute when I am unable to fulfill my responsibility. I understand that if I do not meet these requirements, volunteering hours will be assigned to me with no choice of time, my class enrollment will be later than the standard, and I may possibly not be allowed to return to CCG next year
